WHEREAS, Articles of Incorporation have been adopted for the regulation of the affairs of the Corporation;

WHERAS, it is deemed to be in the best interest of the Corporation and its prospective shareholders that the Articles of Incorporation be adopted as the Articles of Incorporation of the Corporation; and

WHERAS, under Corporations Code 5134, the Sole Incorporator is authorized to adopt the Articles of Incorporation:

RESOLVED, that the Articles of Incorporation attached to these resolutions are adopted as the Corporation's Articles of Incorporation; and

RESOLVED, FURTHER, that the secretary of the Corporation is authorized and directed to execute a certificate of the adoption of these Articles of Incorporation, to insert the Articles of Incorporation as so certified in the minute book of the Corporation, and to see that a copy of the Articles of Incorporation, similarly certified, is kept at the principal office of transact the business of the Corporation.

It was moved that we accept the Articles of Incorporation by Yolanda Sue Gruwell and Seconded by George Anaya and unanimously passed. These were signed and given to Patty

Patty will pay for the filing and be reimbursed. The board members are asked to read and give a yea or nay to the Conflict of Interest Policy by letting Patty know.
