# **Bylaws/Discussion:**

<u>Teen Group:</u> Mark Jones is the husband of the librarian. The librarian will need to be contacted. Susie Richter said she was going to training through the library for Teen involvement training. We should contact the local Boy Scouts, 4-H, and Schools.

Project: Build mailbox/birdhouse's for distribution of free books. Possible Eagle Scout project or 4-H project. These are often located at bus stops or streets where an eye can be kept on them. It was suggested that Terry Godard (sp?) the Yolo Blacksmith may help. Susie Richter will check with schools.
